Resolution 52-2020

WHEREAS, Planet Networks, Inc. ("Planet Networks"), having a business address at 4 Park Place, Newton, NJ 07860, is a provider of telecommunications services that is authorized by the New Jersey Board of Public Utilities to provide local exchange and interexchange telecommunications services throughout New Jersey; and

WHEREAS, Planet Networks has petitioned the Borough of Ogdensburg ("Borough") for consent to use the public rights-of-way to place its telecommunication facilities aerially on existing and new utility poles and/or in underground conduit; and

WHEREAS, the Federal Communications Commission has held that that "an effective prohibition [under the Telecommunications Act of 1996] occurs where a state or local legal requirement materially inhibits a provider's ability to engage in any of a variety of activities related to its provision of a covered service ... not only by rendering a service provider unable to provide an existing service in a new geographic area or by restricting the entry of a new provider

in providing service in a particular area, but also by materially inhibiting the introduction of new services or the improvement of existing services." Declaratory Ruling and Third Report and Order, WT Docket No. 17-79; WC Docket No. 17-84, FCC-18-133A1, at para. 36, p. 15-16; and

WHEREAS, Planet Networks has or will enter into agreements with the utility companies for the use of their poles and will provide the Borough with evidence of such agreements prior to starting work on the poles; and

WHEREAS, N.J.S.A. 48:3-19 provides that "[t]he consent of the municipality shall be obtained for the use by a person of the poles of another person unless each person has a lawful right to maintain poles in such street, highway or other public place;" and

WHEREAS, N.J.S.A. 27:16-6 provides, in part that "[t]he board of chosen freeholders shall not grant an easement, right of way, or use in, under or over, any portion of a county road in a municipality, unless the governing body of the municipality ... shall consent thereto;" and

WHEREAS, N.J.S.A. 46:17-8 provides that "[a]ny telegraph or telephone company organized under the laws of this or any other State, or of the United States may erect, construct and maintain the necessary poles, wires, conduits, and other fixtures for its lines, in, upon, along, over or under any public street, road or highway, upon first obtaining the consent in writing of the owner of the soil to the erection of such poles, and through, across or under any of the waters within this State and upon, through or over any other land, subject to the right of the owners thereof to full compensation for the same;" and

WHEREAS, N.J.S.A. 54:30A-124(a) provides that a municipality may not impose any fees, taxes, levies or assessments in the nature of a local franchise, right of way, or gross receipts fee, tax, levy or assessment against telecommunications companies but that a municipality may impose reasonable fees for actual services made by any municipal agency; and

WHEREAS, it is in the best interests of the municipality and its citizens to grant consent to Planet Networks.

NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the Borough of Ogdensburg, County of Sussex and State of New Jersey as follows:

- 1. The governing body does hereby grant permission and authority to Planet Networks, Inc. to install fiber optic cables and related facilities on existing utility poles within the public right-of-way and to install new utility poles, upon the following terms and conditions:
 - a) Planet Networks shall adhere to all applicable Federal, State, and Local laws in connection with its use of the public right-of-way.
 - b) Planet Networks shall obtain any applicable permits in connection with the installation of its facilities.
 - c) Planet Networks shall indemnify, defend and hold harmless the Borough of Ogdensburg, its officials, agents, and employees, from and against any claim of liability, damages or loss resulting in bodily injury or property damage arising out of Planet Network's use of the public right-of-way, except to the extent such loss, injury or property damage resulting from the acts or omissions of the Borough.
 - d) Planet Networks shall procure and maintain, at its cost and expense, commercial general liability insurance with limits not less than \$1,000,000 for injury to or death of one or more persons in any one occurrence and \$500,000 for damage or destruction to property in any one occurrence and shall include the Borough of Ogdensburg as an additional insured on said insurance policy and shall provide a copy of the certificate of such insurance to the Borough prior to starting any work.

- e) Planet Networks shall be responsible for the repair of any damage to pavement or any structure arising from its construction, installation, or maintenance of its facilities.
- f) Notwithstanding any provision contained herein, neither the Borough nor Planet Networks shall be liable to the other for consequential, incidental, exemplary, or punitive damages on account of any activity pursuant to this consent.
- g) Planet Networks shall provide the Borough with evidence of an agreement with the owners of the poles prior to starting work on said poles.
- h) The permission and authority hereby granted shall continue for the same period as the grant to parties whose utility poles Planet Network is jointly using.
- i) The Mayor is hereby authorized to execute and the Clerk to attest to any other documents necessary to effectuate the terms of this Resolution.

STATEMENT: This resolution authorizes and consents to Planet Networks, Inc.'s installation of fiber optic cables and related facilities on new and existing utility poles and conduits within the public rights-of-way.

WHEREAS, there is a present need to retain a contractor to perform work necessary to repair the roof of the municipal salt shed; and

WHEREAS, the Borough contacted multiple vendors including SJ Construction and Liberty Roofing to solicit and receive competitive quotes for the work to be performed; and

WHEREAS, SJ Construction, having a business address in Hamburg, New Jersey provided the only responsive quote, attached hereto, in the amount of \$7,500.00; and

WHEREAS, after reviewing the quote provided by SJ Construction, the Borough finds that the proposal is most advantageous, price and other factors considered.

NOW THEREFORE BE IT RESOLVED, by the Borough of Ogdensburg Mayor and Council that Mayor and Borough Clerk are hereby authorized to enter in a contract with SJ Construction, Hamburg, New Jersey for all work necessary to repair the roof of the municipal salt shed in an amount not to exceed \$7,500.00.

OLD BUSINESS

Building/Grounds Differentiations – Councilman Nasisi commented there is nothing new.

Salt Shed Roof – Councilman Nasisi commented we should be getting this set up soon. The resolution was on the consent agenda, the permits are in so as soon as they receive the permits back we will schedule [the repair].

Historical Building Oil Tank – Councilman Nasisi commented he thinks this is the final UST tank other then the ones for DPW by the old recycling garage.

Truck sign on Corkhill – Mayor Hutnick commented he is still working on this with the Chief; we are still having issues with the trucks coming down Corkhill; they are not seeing the signs

and get stuck at the tunnel. A car got backed up into by a truck because they were behind the truck and they didn't see them. There is random property damage in that area. We are going to get larger signs; maybe by the Quarry.

Councilwoman O'Dell asked if the trucks could be stopped at the Quarry.

Chief Gordon comment it is in Franklin.

There was a discussion on where to put a sign, the types of trucks, signs with ordinance numbers and tonnage limit on Kennedy.

Planet Networks, Inc. – Mayor Hutnick commented Mr. Boyle is here from Planet Networks. Mr. McBriar commented item three [on the consent agenda] for tonight's meeting is the resolution authorizing the public right of way by Planet Network, Inc. Mr. McBriar commented he worked with Mr. Boyle; there was sufficient documentation/agreements with the owners of those poles. There is nothing new to add.

Mayor Hutnick asked what is the next step going to be?

Mr. Boyle explained we can request permission from the owner of the pole; once we get that permission then we go ahead and install.

Mayor Hutnick asked what is the plan for distribution to the houses from Main Street?

Mr. Boyle commented that remains to be seen at this point; right now, at this point it is basically given the path through town. Right now, we don't have fiber in Ogdensburg at all we have fiber in Franklin and in Sparta. We have to figure out we are going to serve the areas and start serving citizens. We have a website called GetPlanetfiber.com and it lets people check to see if there is service and it logs where there is interest; people can put in their email address in.

2013 Chevrolet Tahoe SSV – Councilwoman Slater commented there is nothing new; she, Mike and Eric are working through it.

NEW BUSINESS

Recycling Center – Mayor Hutnick commented the recycling center opened on Saturday; it was very successful. Everyone was courteous, some people were not happy the way they had to bring their recycling in. No plastic bags are allowed at all, plastic bags are not recyclable. The dumpsters started off empty we filled them to the top with the lids closed so it wasn't blowing all around and the center closed around 11:15 because all three dumpsters were completely full. When the resident comes in and you don't recognize them you have to ask them for a photo ID. Any cardboard boxes have to be broken down flat; you can't have a bunch of boxes stacked in one big box it all has to be flattened. Recycling has to be rinsed and washed clean. We are following the rules that are being told to us from the recycling company this isn't a sudden change these have been the rules the entire time they just weren't enforced. If we don't do this they will not pick up the recycling curb side or the dumpsters.

Councilwoman Slater asked if the Facebook page was updated.

Mayor Hutnick replied the Facebook page has it on there he has to update with no plastic bags and explained.

Councilwoman Slater asked if we should do another mailing just to make sure it's out there for those who don't check Facebook.

Mayor Hutnick commented he is also working on the garbage rules and the bulk rules. If a refrigerator is put on the curb for bulk pickup they have to have a certified freon free sticker on

them from a licensed company that is in charge of removing freon. If it not there they will not pick up the refrigerator.

Mayor Hutnick explained washer and dryers you are allowed to put one out at a time and microwaves they said they would take but that is the extent of the electronics. The reason they accept microwaves is because refrigerators now washers and dryers don't have electronics in them. They cap it off with microwaves.

Mayor Hutnick explained he worked the recycling center last Saturday and asked for volunteers for this Saturday. This was discussed.

Bodycam – Councilman Alvarez explained it took a while but the company for the body cam's will be coming to Borough Hall eleven in the morning this Friday to met with him and the Chief. Hopefully some of the other guys attend. The company will show us how they work and show us videos. Hopefully we can get these as quickly as possible.

Mayor Hutnick asked if anyone else from the Council would like to add anything.

Councilman Alvarez asked about getting the life guards these certain types of bags to use while they are on duty to have their equipment around them and they would not have to search for anything. So basically, we would need six bags. He would like to talk to Councilwoman O'Dell when he sees her.

Mayor Hutnick commented worked that out with Councilwoman O'Dell.

Councilwoman Slater moved, Councilwoman O'Dell seconded motion to open the public session of the meeting. All were in favor.
