As you know the paper road known as Orchard Street does appear on the tax maps unless there is anything of record he thinks it is safe to say it is still owned by the Borough but he will report back when he hears back from the title company.

First Aid Squad – Councilwoman O'Dell commented she was unable to make the meeting with Anthony Nasisi and Alan Arduini; maybe Councilman Nasisi has something else to add.

Councilman Nasisi commented he met Mr. Arduini and walked the building; he let them know if he would ask them to remove underground oil tank and install one that is above ground. Councilman Nasisi commented he has a tank he would donate to the first aid building it is a 275 tank for outdoor use. We will have it removed and we are looking into see if there is any record on file with the County for the septic system. This will take a couple of months to do this transfer. Councilman Nasisi commented he doesn't think it is necessary to leave on the agenda.

Councilman Alvarez commented he has to leave the meeting via phone at this time [7:14pm] and will try to get back to the meeting.

Councilman Nasisi explained the first aid squad will need some area to store first aid equipment that they think the police department will find useful to replenish their supplies as we move forward and maybe move some to the municipal building.

Mayor Hutnick commented in last weeks paper it was stated that Sparta ambulance squad would be covering Ogdensburg. That was not true that is a miss quote. Mayor Hutnick commented what I believe I said was that we would be looking at the different local squads but he did not specify Sparta was covering Ogdensburg. They are not covering Ogdensburg.
