2021 Budget

Mike Marceau, CFO explained this year the State is more behind then normal; introduction to the budget is by March 30th or the first meeting in April, adoption of the budget would be by the second meeting in April or the first meeting in May. Covid-19 has affected everyone; there is a loss of revenue and we are waiting on the State as to how to proceed with the three-year average.

Mr. Marceau referred to his hand out current fund expenditure budget 2021, current fund revenue budget 2021, water utility expenditure budget 2021 and water utility revenue budget 2021. Mr. Marceau went line by line explaining each line item; postage will be divided different in this year budget as well as computer services OE.

There was a discussion on hiring a new police officer and DPW employee, the possibility of using clean community funds for street sweeping, additional cleaning for buildings due to COVID, testing and repairing the water tanks, grants and engineering costs, recycling expenses and using old grant money and surplus.

The next budget meeting workshop will be held February 1, 2021 at 6:00PM.
