#### **OLD BUSINESS**

Mayor Hutnick asked if anyone had any updates on old business.

Councilman Nardini gave an update on **Well #3**. We did get tracking devices installed and we did the repair not the full replacement. The company that did the work said the there was humidity corrosion on the unit so they recommended we get a dehumidifier so adding a dehumidifier and repairing the control board instead of replacing it. The dehumidifier is there that will be another maintenance thing so we an address some concerns in the other buildings.

Councilman Nardini commented on **Beardslee Hill Loop**. Councilman Nardini commented to take this off for now. We are going to address with the storm water grant that we have. We just need to wait for Predmore [to be done] to wait and see what funds are left to use for this project.

Councilman Nasisi asked for some direction on **Borough property/ sales**. Councilman Nasisi commented we previously had someone interested in the parcel we have, he has been asked several times. Is this something we should be working with Land Use or Council.

Mayor Hutnick commented the Land Use Board can look at that property there. Councilman Nasisi commented they can make sure it is zoned property. Mayor Hutnick commented Borough property can't be sold it has to go to auction.

There was a discussion the property and procedure as to selling Borough property.

Mayor Hutnick commented we can bring this up at the next Land Use Board meeting.

First Aid Squad- Councilwoman O'Dell commented nothing new. Councilman Nasisi commented on the oil tank that still needs to be removed and explained.

Mayor Hutnick commented the First Aid Squad is responsible for all financials. The Borough should stay out of it or anyone involved with the Borough.

Paper Road (Orchard Street) – Mayor Hutnick commented we can remove this from the agenda; when Mr. McBriar has an update, we can add this back on.

Main Street Zoning Analysis – Mayor Hutnick commented we are still working with Land Use on this.

Budget – Mayor Hutnick commented our next budget meeting will be March 15, 2021 at 6:00pm.

Councilman Nardini asked Ms. O'Dell if they ordered the slide yet. Ms. O'Dell commented no, we are still waiting on the insurance and our decision on who is going to install it. The insurance company recommends to have the company install it. There was a discussion on installing the slide.

### **NEW BUSINESS**

Grants – Councilman Nardini commented the catch basin grant the work is all done. Mike Vreeland told him everything is on his desk and completed then he is going to submit it to the State. There were no major changes like we had with Plant Street. Councilman Nardini commented moving on with Passaic and Edison; he is going to combine the projects in a plan. We are not adding guard rails or anything else because it is one big paving job and we might get a better deal too. So, he is going to get the specs together for that.

Heaters Pond Usage – Mayor Hutnick commented it is March the Pond will be opening in June; we need to prevent everything that has happened in the last few years and create a clear

definition of goals and regulations which include pond usage hours of operation, guest passes, parties, pavilion anything that has to do with the property we need to iron this out.

Mayor Hutnick commented on the Pond opening hours in 2019; it was open Monday through Friday 12-5 and the weekends not sure. Last year we went way over the budget on salaries extending the hours of the pond and he doesn't think we had any extra usage of the pond to justify the costs.

Councilwoman Slater commented wasn't it 12 - 6.

Councilwoman O'Dell commented she believes it was 11-6.

Councilman Nasisi commented it was 12-6.

Councilwoman O'Dell commented the lifeguards were there from 11 doing their clean up and getting ready for the day and swimmers were allowed 12-6. It really only added 2 hours per day. There were people that would start to show up around 11 by 6:00 the lake was still being used. On the weekend we opened 12-6.

Councilwoman Slater commented when she had it, the hours were 12-6 Sunday through Saturday. It is listed in the code book what the hours are.

Councilwoman O'Dell commented she is trying to come up with a way to track what the usage is and explained. Swim team needs to check in to avoid all the chaos we had last year.

Councilwoman Slater asked if it would be helpful to have a log book to sign in and out when they are done.

Councilwoman O'Dell commented she was thinking of that; with people coming [from swim team] maybe they need to start getting guest passes for the swim clinic season only for whoever their siblings are and wanted to swim. Pay all in the beginning and they would automatically be in the list. With that being said it would be fair to raise the prices a little bit. Councilwoman O'Dell commented she has three lifeguards the are returning. She could operate with four guards.

Mayor Hutnick asked that is two guards on with every shift, correct.

Councilwoman O'Dell commented yes, that is a head life guard plus another guard with them. If somebody is out sick or vacation time then the lake gets closed that day.

There was a discussion on the prices for guest passes, residents, guest passes for the swim team clinic season, not to increase the cost for residents, swim team season guest pass for the five-week period, where to purchase the passes and log book.

Councilman Slater commented the payment [for swim team clinic session pass] would have to be a separate payment to the Borough; it can't be tagged on with the swim team and have the swim team pay us.

The discussion continued on the prices for passes, go through Borough Hall and/or lifeguards, get the form created and send it to the Borough, by time swim team season comes passes they should have already received their passes, everything needs to be put in writing, parties and rentals, the pond pavilion has always been free for residents as long as they clean up, some changes were already updated several years ago when we updated the code book and the raft that was ordered for use at the pond.

Mayor Hutnick commented salaries for lifeguards have we finalized the price. Councilwoman O'Dell commented are they entitled to a raise or do we keep them the same as we did last year.

Mr. Marceau commented in theory they are in compliance with the new minimum wage, you could give them a raise but it would have to be via the salary ordinance. Councilwoman O'Dell asked if Mr. Marceau could advise her of this. Mr. Marceau commented he will take a look and give you some options.

Mayor Hutnick asked Councilman Nardini if he could make sure ORA has finalized their insurance and it is all complete. Councilman Nardini commented he believes it is all taken care off.

#### **PUBLIC SESSION**

Councilwoman O'Dell moved, Councilman DeMeo seconded motion to open the public session of the meeting. All were in favor.

Thomas Kuplin, 39 Glenbrook Road, Ogdensburg. Mr. Kuplin commented he lived here for over 37 years, he put his property tax payment in his mailbox in front of the building on February 3<sup>rd</sup>, which is the first really clear day after the big snow storm and apparently it never got anywhere it just seems to have disappeared because it was never cashed. He received the delinquency notice and of course the charge for interest that was accrued from not paying on time. Mr. Kuplin commented he was told to bring this before Council, it can be handled like a business. So, he is here to present this to you; he placed the payment in your mailbox and it never seemed to go any further than that.

Mayor Hutnick asked are you looking for the sixty-four dollars back. Mr. Kuplin commented yes, he did pay the tax as soon as he found out this happened.

Mayor Hutnick commented he doesn't have a problem with this and asked Mr. McBriar and Mr. Marceau the process.

Mr. Marceau commented you would have to pass a resolution waiving the late fee and issuing a refund.

Mayor Hutnick asked if the later fee was paid. Mr. Kuplin commented yes, he didn't want to continue any further charges.

Mr. Marceau commented we could also due a resolution and give you a credit of the interest payment to the following quarter.

Mayor Hutnick asked if this was acceptable.

Mr. Kuplin commented yes, that would be fine.

Mr. McBriar asked Mr. Kuplin would be willing to sign a certification as to the facts that you just presented.

Mr. Kuplin commented yes, he would.

Mr. McBriar commented he would prepare the resolution for the next Council meeting and would reach out to Mr. Kuplin for the background.

There being no further business from the public, Councilman Nardini moved, Councilman Nasisi seconded motion to close the public session of the meeting. All were in favor.
