Resolution 53-2021

WHEREAS, N.J.S.A. 52:14-15(f) authorizes municipalities to provide for mandatory direct deposit of net pay for all employees on or after July 1, 2014 subject to any exemptions deemed necessary by the governing body; and

WHEREAS, the Chief Financial Officer of the Borough of Ogdensburg ("Borough") recommends that the Borough adopt a requirement for mandatory direct deposit of net pay because it will increase the productivity of the Finance Department, and decrease or eliminate costs and fees associated with producing checks and replacing lost checks; and

WHEREAS, this policy will require that, unless exempted, all employees and elected officials of the municipality indicate, in writing to the Chief Financial Officer, the specific banking institution(s) and designated checking account(s), savings account(s) or share account(s) to which the deposit shall be made on behalf of the employee or elected official; and

WHEREAS, this policy will also require that, unless exempted, all employees and elected officials of the municipality enroll in the payroll portal administered by the Borough's payroll company in accordance with instructions provided by the Finance Department and/or payroll company; and

WHEREAS, this policy shall not apply to Borough Crossing Guard and Lifeguard employees, and said employee positions are specifically exempted from the Borough's mandatory direct deposit requirements set forth herein; and

WHEREAS, the Borough desires to amend its payroll policy described in Section 4.2 of the Employee Handbook dated April 22, 2020 to reflect this policy.

- **NOW, THEREFORE, BE IT RESOLVED,** by the Borough Council of the Borough of Ogdensburg that, effective August 9, 2021 pursuant to <u>N.J.S.A.</u> 52:14-15(f), mandatory direct deposit of net pay for all employees and elected officials of the Borough shall be made to the specific banking institution(s) provided by each employee or elected official, except for the employment positions of Borough Crossing Guard and Lifeguard.
- **BE IT FURTHER RESOLVED,** that unless otherwise exempted, all employees and elected officials must comply with the Borough's direct deposit policy as described herein.
- **BE IT RESOLVED** that Section 4.2 of the Borough Employee Handbook dated April 22, 2020 is hereby amended, effective immediately, as follows:

"Paychecks shall be issued in accordance with the Borough's direct deposit payroll policy on Friday of the payroll week, except for various part-time positions, whose paychecks shall be issued on a monthly basis, and the Mayor and Council whose paychecks shall be deposited on a quarterly basis. When the normal day for issuance of checks falls on a holiday, checks shall be issued on the last preceding workday."

Administrative Fees for Recreation Areas and Facilities- Councilman DeMeo commented he and Mr. McBriar are still working on this; we should have it complete by the end of the month. Mr. McBriar commented that would cover items one, two and four.

Establishment of Ogdensburg Borough Parks & Recreation Committee- Mayor Hutnick commented this is the ordinance we just [introduced]. What that is we have an ORA which has always been for sports and youth activities, it has never had an organization for everyone else, senior citizens, small children and everyone in the middle; for fun nights, dances, pickle ball and all that stuff. Mayor Hutnick commented he is going to form a committee of mixed members of the community to see if we can put something together; to create community events that are not sports related.

RFP for water treatment operator - Mr. McBriar commented the RFP water treatment operator ad was published we still have a little more time to receive applications. We will provide an update at the next meeting with respect to that.

Fire Marshall – Councilwoman Slater commented the fire marshal we just tabled that motion and zoning officer we have applications we need to review. Councilwoman Slater commented she would like to see if Mr. Kervatt can join the interview since he knows what we are talking about.

Zoning Officer – see above.

Fire Department Family Fun Day- Councilwoman Slater commented the Fire Department Family Fun Day is still on schedule we just approved their raffle. Councilwoman Slater commented we can probably take that off for the next meeting.

Historical Society Building-Councilman Nardini commented he did speak to Mr. Kibildis and DPW we do have some stone; the stone we have is good enough and explained what DPW will do. Councilman Nardini commented Robin you can take this off.

Center Street Generator - Councilman Nardini commented he put Center Street Generator on here; he did start to make some calls he spoke to Jackie from JCP & L; regarding a generator for

Center Street. Councilman Nardini commented he wanted to see if there was any availability to get grants from the State or Federal for generator for Center Street and the Fire House as well. Senior Citizen of the year – Mayor Hutnick commented two years ago we had Senior Citizen of the year, 2020 was a bust, 2021 he thinks we should continue the started tradition of picking a Senior Citizen of the year or a Senior Couple of the year. The public can make suggests and email himself or Robin.

Councilwoman Slater commented do you want to announce it at Ogdensburg Family Fun Day. Mayor Hutnick commented if we can get a committee in time then yes.

PUBLIC SESSION

Councilman Alvarez moved, Councilman DeMeo seconded motion to open the public session of the meeting. All were in favor.

Dion Derkach, 20 Corkhill Road, Ogdensburg commented we would like to talk about the signage on Corkhill Road, we still have a major problem down there with trucks and explained one of the situations.

Mark Boyer, 25 Corkhill Road, Ogdensburg commented there has been numerous incidents where he suffered property damage and explain. Mr. Boyer commented this is an ongoing problem we report [to the police] sometimes they are able to get the offending drivers and issue a summons but Dion has had his lawn, driveway and curbs torn up numerous times. Mr. Boyer commented he ended up putting a big bollard on the other side of his driveway to protect his vehicles from people that are turning or backing up. He has seen numerous dump trucks and vehicles backing up on either side of Corkhill Road and explained different incidence that have happened. Mr. Boyer explained a list he has to keep a record of all the incidents and continued to explain different incidents that have occurred on Corkhill with trucks. This is a problem and he would like to be part of the solution.

Mr. Derkach asked if there something we can do regarding a white sign. He explained a sign he noticed in Franklin.

Councilman Nardini asked can we replace one of them maybe with a little more florescent background so it reflects a little more.

Councilman DeMeo commented is there something we can do to contact google maps.

Craig Taylor, 170 Kennedy Ave. Ogdensburg commented he is on the corner between Corkhill and Kennedy Avenue. Mr. Taylor commented he had a lot of problems with the Quarry, he has had a lot of problems with the trucks coming [from there]. The property behind him just sold on Corkhill Road; they had a surveyor came in to survey their property line; he told Mr. Taylor his property line is out in the middle of Kennedy Ave. Mr. Taylor explained the survey is marked in orange paint. This corner has been an ongoing problem and explained. Mr. Taylor also mentioned a need for a guide rail by his house.

Mayor Hutnick asked Mr. Boyer if he could provide him with a copy of his notes; email them to Robin. We will take those notes and met with the Chief and come up with a plan.

There was a discussion on coordinating with Franklin and signs.

Chief Gordon commented they may not see these signs; one of the things he was going to do is find red and white signs that are DOT compliant that go around the corner and explained his experience the last few years and suggested having signs in English and Spanish. Chief Gordon explained in Franklin there are two signs they are the same yellow signs same size they have been there twenty years maybe Franklin can put up something bigger like the quarry has on the corner. They have a 3 by 5-foot sign you can see a mile away.

Chief Gordon explained Franklin has an industrial park which address happens to be 12 Corkhill Road. Several times he dealt with truck drivers that were going to 12 Corkhill Road which is a house [in Ogdensburg]. Chief Gordon commented whether it is a GPS or driver input error that's one thing we can't tell and explained reaching out to the owner of 12 Corkhill Road in Ogdensburg and having a sign put up there. Chief Gordon explained the different trucks and drivers and sometimes they only are in this area once. Chief Gordon commented the truck that was stuck on Yurchak came out of Hamburg and explained.

The discussion continued on the quarry, Corkhill Road, and to have tunnel ahead put on the sign.

Mayor Hutnick commented email me your notes and he will met with Chief Gordon. Mayor Hutnick commented he will also call Franklin's Mayor regarding this problem.

There being no further business from the public, Councilwoman Slater moved, Councilman DeMeo seconded motion to close the public session of the meeting. All were in favor.
