Resolution 64-2021

OLD BUSINESS

Administrative Fees for Recreation Areas and Facilities- Mayor Amendments to Regulations for Municipal Recreation Areas – Mayor

Mayor Hutnick commented we are bypassing number one and two for now.

Senior of the year – Mayor Hutnick August Rutkowski, has been named senior of the year. Mayor Hutnick is waiting to hear back from the family fun day committee as to what time he is to appear so we can do this presentation in public. Mayor Hutnick commented a street sign has been ordered. The current street sign will come down and be presented to the Sabourin Family. If we can get Pat Sabourin to come over and we can present that sign to her.

NEW BUSINESS

Swim Docks- Councilman Nardini commented the swim docks on the one side with the last hurricane the pipes were bent; DPW went there to try and straighten them out and couldn't. Councilman Nardini commented he wanted to see if anyone cared if he went out and got a quote to find out what it would take to repair them.

Water Tank Cleaning – Councilman Nardini commented he had this on pause for a little while because we had a temporary water operator but now we have someone permanent the cleaning is going to be done hopefully during one of the breaks of school. We are not going to do it while school is in session but we will do it one of the teacher conference weekends. We are trying to get that scheduled.

Water Rates – Councilman Nardini passed around a spreadsheet for an increase in water rates. Councilman Nardini explained the spread sheet there were sample of increase for fifty cents, forty cents, thirty cents and twenty cents. The spread sheet had the average increase a year for each of the increases. The increase would help fuel the fund balance on the water side with this modest increase.

Mayor Hutnick asked are you looking for which one we would like to see.

Councilman Nardini commented he is looking to see if that top line is do able. Councilman Nardini commented on our infrastructure, the pipes are so old there is difficulty and very

minimal grants that are available, there are loans he looked at with Mike and there are loans we can get if we have to do major repairs. Councilman Nardini recommended the highest increase.

Mayor Hutnick commented because are highest is still probably lower then [others]. Mayor Hutnick asked if we need to take a vote on this.

Mr. McBriar commented we would put a resolution on the agenda to introduce this idea; he will be happy to put together a resolution for consideration at the next meeting.

Ms. Hough commented should it be an ordinance because it has to be codified and put in our code book.

Mr. McBriar commented he will look at the sources.

Councilman Nardini commented it is in the code book.

Mr. McBriar commented in the code book would require and introduction second reading, public hearing but if there is a general consensus he will prepare that ordinance based on the fifty cents increase.

Councilman Nardini commented the goal would be to do this for January. Effective January 1.

Mr. Marceau commented whatever we bill in February is going to be based on the reading from the previous quarter which would be the fourth quarter of this year. So, try and get it effective as soon as possible so it effects the next billing.

Councilman Nardini commented probably has to be before she does the billing so December 1 might be the target or even earlier.

Mr. McBriar commented he will prepare that for the next meeting.

Internet/emails – Councilman Nardini explained how slow the emails are for borough hall and how there are issue upstairs with how long it takes for uploads related to body cam's and videos. Councilman Nardini commented we have a 10mg download and 1mg upload in this building which is unheard of; DSL will not get faster, we can pay for an upgrade but the lines for DSL are very old in the town and very weak. Councilman Nardini explained other options and costs.

There was a discussion on the different options. Councilman Nardini will work with Kim on the project.

Councilwoman Slater commented she has a question from the fire department; the garbage dumpster there keeps shrinking in size, every time they bring a new one they are placing it out with a smaller one. The fire department would like to know why.

Mayor Hutnick commented also with the fire department nobody notified them there was a school vote tomorrow and they rented the hall for tomorrow night.

Ms. Hough commented no, they were notified. Mayor Hutnick asked who did you notify. Ms. Hough commented she notified Eric [Slater]. Councilwoman Slater commented that was for November 17. Ms. Hough commented November 17 was for tax sale; when I received the first papers from the Attorney about the School Board Election I emailed the fire house and said that there is a special election. Councilwoman Slater asked did you CC me on it? Ms. Hough commented I should have. Mayor Hutnick commented they are making it work but they had the hall rented for tomorrow night; they are working around it. The election is until eight. Councilwoman Slater commented on the email; the election was with other stuff so he [Eric] probably didn't look at it [the email]; you have stuff for Gordon and Chris and everyone else on

here [the email]. Ms. Hough commented it all had to so with the election; I did one email and addressed each thing that would have to be done. Councilwoman Slater commented Eric won't pay attention to stuff like that; he needs a direct email to him.
