Mr. McBriar commented the first order of business is resolution 73-2021; before the Council considers that the Mayor has a public statement pertaining to the resolution he would like to read;

MAYOR HUTNICK'S PUBLIC STATEMENT REGARDING RESOLUTION 73-2021

RESOLUTION 73-2021 IS AN ACTION TO APPROVE THE SETTLEMENT AND GENERAL RELEASE BETWEEN THE BOROUGH AGREEMENT OGDENSBURG AND JOSEPH SANFILIPPO. IF APPROVED BY THE GOVERNING BODY, THIS RESOLUTION WILL BRING TO A CONCLUSION A COURSE OF EVENTS THAT STARTED BACK IN NOVEMBER OF 2017, WHEN DISCIPLINARY CHARGES WERE BROUGHT AGAINST SGT. SANFILIPPO. SHORTLY AFTER THE CHARGES WERE BROUGHT, THE SUSSEX COUNTY PROSECUTOR'S OFFICE BECAME COMMENCED CRIMINAL PROCEEDINGS AGAINST INVOLVED AND SANFILIPPO, WHO WAS SUSPENDED WITHOUT PAY WHILE THE CRIMINAL CHARGES WERE PENDING. MORE THAN THREE YEARS LATER, ON FEBRUARY 3, 2021, THE PROSECUTOR'S OFFICE MADE THE DECISION TO DISMISS ALL CRIMINAL CHARGES AGAINST SGT. SANFILIPPO.

DURING THE MORE THAN THREE YEARS THAT THIS MATTER WAS HANDLED BY THE PROSECUTOR'S OFFICE, THE BOROUGH AND ITS ATTORNEYS HAD NO CONTROL OVER THE PROCEEDINGS AND NO ABILITY TO DECIDE HOW THE MATTER SHOULD PROCEED. FURTHERMORE, THE DECISION TO DISMISS THE CRIMINAL CHARGES WAS EXCLUSIVELY WITHIN THE PROVINCE OF THE PROSECUTOR'S OFFICE. THE BOROUGH HAD NO INPUT AND NO CONTROL OVER THAT DECISION. HOWEVER, THAT DECISION HAD SIGNIFICANT CONSEQUENCES FOR OGDENSBURG. UNDER NEW JERSEY LAW, ONCE PENDING CRIMINAL CHARGES AGAINST A POLICE OFFICER ARE DISMISSED, THE OFFICER IS ENTITLED TO BE REINSTATED TO HIS FORMER POSITION AND PROVIDED WITH BACK PAY FOR ANY PERIOD OF SUSPENSION WITHOUT PAY. SO, AS A RESULT OF

THE PROSECUTOR'S DECISION TO DISMISS THE CRIMINAL CHARGES AGAINST SGT. SANFILIPPO, THE BOROUGH IS OBLIGATED TO REINSTATE SGT. SANFILIPPO AND PROVIDE HIM WITH BACK PAY FOR THE MORE THAN THREE YEARS THAT HE WAS SUSPENDED WITHOUT PAY.

THIS MUST BE DONE BY LAW AND WE HAVE NO OPTION BUT TO MAKE THE BACK PAY AWARD. LET ME REPEAT THAT AGAIN, WE ARE OBLIGATED BY LAW TO REINSTATE SGT. SANFILIPPO AND MAKE THE BACK PAY AWARD BECAUSE THE PROSECUTOR'S OFFICE DISMISSED THE CRIMINAL CHARGES. WE HAVE NO OPTION BUT TO TAKE THIS ACTION.

BECAUSE THE ADMINISTRATIVE DISCIPLINARY CHARGES WERE STILL PENDING AGAINST SGT. SANFILIPPO EVEN AFTER THE CRIMINAL CHARGES WERE DISMISSED, THE BOROUGH'S ATTORNEYS AND SGT. SANFILIPPO'S ATTORNEY WORKED TOGETHER IN AN EFFORT TO REACH A SETTLEMENT OF THOSE MATTERS. BOTH THE BOROUGH AND SGT. SANFILIPPO WERE IN FAVOR OF PUTTING THESE MATTERS TO BED AND MOVING ON. FOR THE LAST 7 MONTHS COUNSEL HAS BEEN WORKING ON THE TERMS OF A SETTLEMENT. THE SETTLEMENT AGREEMENT IS DETAILED AND ADDRESSES MANY POINTS. THE KEY POINTS INCLUDE:

- SGT. SANFILIPPO WILL BE REINSTATED TO THE OGDENSBURG
 POLICE DEPARTMENT SUBJECT TO HIS SUCCESSFUL COMPLETION OF
 A FITNESS FOR DUTY EXAMINATION AND INTERNAL AFFIARS
 INVESTIGATION, AND PROVIDED HE IS APPROVED FOR REARMING
 BY THE PROSECUTOR'S OFFICE;
- SGT. SANFILIPPO HAS AGREED TO A 90 DAY SUSPENSION WITHOUT PAY AND OTHER ADMINISTRATIVE CONSEQUENCES STEMMING FROM THE ADMINISTRATIVE DISCIPLINARY CHARGES;
- THE BOROUGH WILL PAY SGT. SANFILIPPO \$348,514.81 IN BACK PAY.
- SGT. SANFILIPPO WILL RELEASE THE BOROUGH FROM ANY AND ALL CLAIMS AND LIABILITY INCLUDING ANY CLAIM FOR LEGAL FEES, WHICH HE COULD HAVE SOUGHT FROM THE BOROUGH UNDER NEW JERSEY LAW.

THE BACK PAY AWARD IS A SIGNIFICANT SUM FOR THE BOROUGH TO PAY; HOWEVER, AS I PREVIOUSLY STATED, THE BOROUGH HAS NO OPTION BUT TO MAKE THE BACK PAY AWARD GIVEN THE DECISION BY THE PROSECUTOR'S OFFICE TO DISMISS THE CRIMINAL CHARGES. OUR CFO, MICHEL MARCEAU, IS WORKING CLOSELY WITH OUR AUDITORS AND ATTORNEYS TO OBTAIN APPROVAL FROM THE LOCAL FINANCE BOARD IN TRENTON TO BOND THE COST OF THE BACK PAY AWARD AND SPREAD THE COST OVER MULTIPLE YEARS SO AS TO LESSEN THE TAX IMPACT ON OUR RESIDENTS. WE ARE OPTIMISTIC THAT OUR PLAN WILL BE APPROVED, BUT THERE IS NO GUARANTEE. IF OUR PLAN FAILS WITH THE LOCAL FINANCE BOARD, THEN WE WILL HAVE TO PAY-OFF THE BACK PAY AWARD OVER A 36 MONTH PERIOD.

AS YOUR MAYOR, I SUPPORT THE SETTLEMENT AND ASK MY COLLEAGUES TO APPROVE IT BY PASSING RESOLUTION 73-2021. THE SETTLEMENT AGREEMENT PUTS AN END TO THIS MATTER, WHICH HAS BEEN ONGOING FOR FOUR (4) YEARS NOW AND WILL ALLOW US TO MOVE FORWARD. AND, UNDER THE CIRCUMSTANCES OUR OPTIONS ARE LIMITED. FAILING TO SETTLE THIS MATTER NOW WILL ONLY RESULT IN ADDITIONAL LITIGATION AND LEGAL FEES FOR THE BOROUGH AND WILL NOT REDUCE OR ELIMINATE THE BOROUGH'S OBLIGATION TO MAKE THE BACK PAY AWARD TO SGT. SANFILIPPO. SO, THE TIME HAS COME TO RESOLVE THIS MATTER AND MOVE FORWARD.

WHEREAS, during the pendency of the criminal proceedings, the Borough issued Sanfilippo a second Preliminary Notice of Disciplinary Action dated January 15, 2019, alleging conduct impacting his ability to serve as a police officer under the <u>Giglio/Brady</u> doctrine; and

WHEREAS, on December 10, 2020, the SCPO agreed to dismiss all criminal charges and/or offenses stemming from the initial Preliminary Notice of Disciplinary Action effective January 30, 2021; and

WHEREAS, the parties recognize the uncertainty of the potential outcomes and the fees and costs associated with pursuing the prosecution and defense of the pending Preliminary Notices of Disciplinary Action; and

WHEREAS, the parties wish to reach a settlement of the pending Preliminary Notices of Disciplinary Action, and resolve all claims and potential claims between them as set forth in the Settlement Agreement and General Release attached hereto.
