Resolution 77-2021

WHEREAS, the Borough of Ogdensburg ("Borough") previously instituted a Home Improvement Program ("Program") for the purpose of providing low cost home improvement financing to qualifying homeowners; and

WHEREAS, as part of this Program, the Borough granted a loan in the principal amount of \$20,000.00 to be used to rehabilitate property located at 51 Beardslee Hill Road, Ogdensburg, New Jersey, identified on the Official Tax Maps of the Borough as Block 13, Lot 41; and

WHEREAS, said loan was secured by a mortgage in favor of the Borough dated June 13, 2007 which was recorded in the Sussex County Clerk's Office in Book 8346, at Page 150-153 (four pages); and

WHEREAS, the loan in the principal amount of \$20,000.00 was paid in full evidenced by check number 12931 issued to the Borough and endorsed by Intact Title Agency of New Jersey, Inc.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Borough of Ogdensburg that the Mayor and Clerk are hereby authorized to execute a discharge of mortgage relative to the above-referenced property and take such further actions as are necessary to effectuate the purpose of this Resolution.

Resolution 78-2021

WHEREAS, the Borough of Ogdensburg ("Borough") holds a mortgage lien against certain real property located at 9 Wallkill Terrace, Ogdensburg, New Jersey ("Property") in connection with the Property owners' participation in the Borough's Home Improvement Program which was established to provide loans to qualifying homeowners for correcting home defects and assisting in achieving compliance with property maintenance standards; and

WHEREAS, the underlying mortgage was given to the Borough by the Property owners on January 19, 2007 for \$15,740.00 with no interest charged; and

WHEREAS, said mortgage was duly recorded in the Sussex County Clerk's Office on January 31, 2007 in Book 7985 at pages 76-79 (4 pages); and

WHEREAS, the Property owners have requested that the mortgage lien which is held by the Borough be postponed, or subordinated to a mortgage to be given to Mutual of Omaha Mortgage, Inc. having an address at 5800 Lombardo Center, Suite 200, Seven Hills, OH 44131 ("Lender") in connection with refinancing the first mortgage on the Property; and

WHEREAS, the Lender requires, as a condition of refinancing, that the Borough's mortgage lien be subordinated to its mortgage; and

WHEREAS, the Borough's mortgage contains a provision limiting the amount that can be subordinated to no more than seventy-five percent (75%) of the *assessed value* of the property at the time of application for new financing; and

WHEREAS, the Borough desires to modify the aforesaid limitation based on an appraisal report provided by the owners in connection with their refinance, which was prepared by Anthony V. DePalma of Alliance Appraisal & Research, LLC, P.O. Box 8, Bloomingdale, NJ 07403, dated October 19, 2021, and which determined the *true value* of the Property to be \$300,000; and

WHEREAS, based on the appraisal report, the amount of the loan to be refinanced is less than seventy-five percent (75%) of the *true value* of the property, which the Borough deems acceptable; and

WHEREAS, the Borough's consent to subordinate its full lien amount shall be expressly conditioned on the refinance mortgage not exceeding the principal amount of \$195,000; and

WHEREAS, the Borough's consent shall further be conditioned on full payment, by either the owners and/or their Lender, of legal fees and costs incurred by the Borough for legal services required to process owners' request for subordination, at the time of closing, as authorized under the mortgage between the Borough and the owners; and

WHEREAS, all other terms and conditions set forth in the Borough's mortgage and mortgage note shall remain in full force and effect; and

WHEREAS, it is considered to be in the best interest of the Borough that the owner's request be accommodated.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Borough of Ogdensburg that the Mayor and Clerk of the Borough of Ogdensburg are hereby authorized and directed to execute a Postponement of Mortgage subordinating the Home improvement Program

Loan in the principal amount of \$15,740.00 to a mortgage given by the owners to Mutual of Omaha Mortgage, Inc., with a principal amount of the mortgage not to exceed \$195,000.00

What would constitute seasonal use would be three or more organized events at that faciality and the range was to be an analysis by the Borough as to how many individuals there would be and other things that are required by the Borough to ensure that municipal facility.

Councilman Nardini commented his concern is the nonprofit. One of the reasons this was changed was because of swim five hundred dollars isn't a reasonable fee for them to absorb. So, the non-profit we did talk about, we had four meeting worth of talking; as long as non-profit exemptions for in town organization whether it is scouts or recreation.

Mr. McBriar commented it is an exemption so it should be clarified and if that is the case he would consider that to be material change to the ordinance. We can circulate a revised draft so we can reintroduce it and hopefully adopt it.

Mayor Hutnick commented he is ok with that. We are going to table this for now.

Ms. Hough asked we have a motion and a second to introduce the ordinance. Mr. McBriar commented whoever moved this if they want to amend their motion to table this that would be appropriate.

Best Practices – Mike Marceau, CFO commented for everyone that doesn't know the State issues a best practice questionnaire every year. They require us to fill it out and basically if the Borough doesn't get enough correct answer regarding best practices they can pull a portion of your State aid. This year's survey was 48 questions, 27 were scored, 15 were not scored. You are required to score 15 of higher to get 100%; the borough had 19 so we passed.
