REGULAR MEETING JUNE 9, 2008

The sixth regular meeting of the Mayor and Council of the Borough of Ogdensburg, Sussex County, New Jersey was held in the Council Chambers of the Borough Hall on June 9, 2008.

Mayor Sekelsky called the meeting to order at 7:00P.M.

Upon roll call, the following council members appeared and answered the call: Altenburg, Blahut, Ciasullo, Hann, Ingerto, Peist.

Notice requirements of the Open Public Meeting Act, NJSA 10:4-6 et. Seq. have been satisfied with a schedule of all meetings, together with the time, location and agenda of same being sent to the NEW JERSEY HERALD and NEW JERSEY SUNDAY HERALD and posted on the bulletin board January 2, 2008.

Councilman Hann moved, Councilman Altenburg seconded motion to go into executive session to discuss police personnel and Borough personnel. Yeas: Altenburg, Blahut, Ciasullo, Hann, Ingerto, Peist.

After returning from executive session, Councilman Ciasullo moved, Councilman Hann seconded motion to open the public session of the meeting. Yeas: Altenburg, Blahut, Ciasullo, Hann, Ingerto, Peist.

Fire Chief, Eric Slater inquired about Ordinance 3-3. Richard Predmore, 15 Predmore Road informed Mayor and Council that the exempt fireman will be donating fish to the Fire Department for the fishing contest. Mayor Sekelsky thanked Donna Paiva for all the help she gave with the Clean Communities project working with the Scouts to clean up Heater's Pond. Kevin Kervatt thanked Mayor and Council for the gazebo up at Memorial Park. He feels it is a great addition to the park. Councilman Ingerto thanked Grinnell for the pavers they supplied and also thanked Dave Swingle for helping lay the concrete pad for the gazebo.

Councilman Ingerto moved, Councilman Altenburg seconded motion to open the public hearing on the Boro Pub. Attorney for the Borough stated the public hearing on the Boro Pub is for various complaints made against them and explained that Mayor and Council has concerns about the complaints prior to renewing their liquor license. The complaints read were disorderly conduct, loud music and property maintenance. Patrolman Gordon, who was in attendance, made a brief statement agreeing to the complaints which were read. Mrs. Armstrong explained that she has bought containers for the outside and has been cleaning up any garbage around the property. Mrs. Armstrong also stated she has gotten smaller speakers to keep the noise level down. Borough Attorney opened up the hearing to the public. Mr. Inglima who lives next store to the Pub commented on the fighting going on and the noise, which is disturbing to his family. Christian Ziegler also spoke and commented on the noise and said it was mentioned to the bartender several time but nothing was done. Mrs. Armstrong said she was never informed about the complaint. Bob Armstrong spoke and had mentioned that the tenants living upstairs have been evicted and the apartment up stairs has been cleaned up. The attorney informed Mrs. Armstrong that the decision on renewal for the liquor license is the decision of the governing body. Mayor Sekelsky thanked everyone for taking the time to give their input on the situation. Councilman Ingerto moved, Councilman Altenburg seconded motion to close the public hearing. Yeas: Altenburg, Blahut, Ciasullo, Hann, Ingerto, Peist.

He would like to amend the property maintenance ordinance to add a fine for property owners who do not keep their lawns maintained. Further discussion will be forth coming. Councilman Blahut discussed briefly a retirement party for Chief Lott.
