REGULAR MEETING SEPTEMBER 11, 2017

The ninth regular meeting of the Mayor and Council of the Borough of Ogdensburg, Sussex County, New Jersey, was held in the Council Chambers of the Borough Hall on September 11, 2017. Mayor Ciasullo called the meeting to order at 7:00 p.m.

Upon roll call, the following Council members appeared and answered the call: Astor, Gunderman, Hutnick, Nasisi, Opilla, Slater. Also in attendance was Borough Attorney Richard Brigliadoro.

Notice requirements of the Open Public Meeting Act NJSA 10:4-6 et. Seq. have been satisfied with a schedule of all meetings, together with the time, location and agenda of same being sent to the NEW JERSEY HERALD and NEW JERSEY SUNDAY HERALD and posted on the bulletin board on January 4, 2017.

Councilman Astor moved, Councilman Opilla seconded motion for approval of items on the consent agenda.

Council discussed Ordinance 7-06, sub-section 3-6.2 paragraph e and agreed on a one time waiver for the Fire Department and ORA for 2017.

Councilman Astor moved, Councilman Opilla seconded motion for adoption of the following resolution.

WHEREAS, on March 11, 2016 the Veterans Administration assigned a 100% disable Veteran rating to Alejandro R. Saldana, who physically resides at Block 3.08, Lot 6, 8 Adams Dr., Ogdensburg, N.J.; and

WHEREAS, the Borough Council approved the determination effective day May 16, 2017 on which Mr. Saldana fully exempt from paying property taxes, thus the Tax Collector entered it onto the tax records for the year 2017 effective May 16, 2017; and

WHEREAS, the amount adjusted is \$3,909.23 for the year 2017. An overpayment for May portion shall be refunded to Mr. Saldana in the amount of \$922.66.

OLD BUSINESS

Mayor informed Council that there is nothing new with Heaters Pond Dam. The pond was treated and the pond water will be lowered soon so work can be started on the dam. Councilman Opilla informed Council that he received another quote for the repair of the Beardslee Hill Drive project from Rich Wingle Contractor, Inc. in the amount of \$21,300, which is \$4,000 more than Hank Sanders Inc., which is \$17,295.00 so the Borough will be using Hank Sanders Inc. The Mayor gave an update on Elizabethtown Gas. Some areas of town had a good response and other areas did not. Elizabethtown Gas feels that another notification to the public would help. Elizabethtown Gas is talking about possibly breaking ground by the end of the year. The Mayor would like to do one more mailer. Mayor mentioned that Presidents Estate is one of the areas that did not have a good response and would like to try and get more people to sign up. Councilman Hutnick spoke about Ogdensburg Day. Everything went off well, the weather was good and it was a great day. Councilman Hutnick feels the need to change the date since September has become a very popular month for other towns having activities as well. Council will discuss changing the date for next year's event.

NEW BUSINESS

Councilman Hutnick spoke about moving the regular meeting in October from October 10th to October 11th so that Council will be able to attend Candidates night. After a brief discussion

Councilman Hutnick moved, Councilman Opilla seconded motion to change the October 10th, regular meeting to October 11th at the regular time in order for Council to attend Candidates night. Yeas: Astor, Gunderman, Hutnick, Nasisi, Opilla, Slater. Councilman Opilla spoke about the pump house and working on a contract for repairs. Councilman Hutnick informed Mayor and Council that the First Aid Squad has donated their spot light to the Borough.

Councilman Gunderman moved, Councilwoman Slater seconded motion to open the public session of the meeting. Yeas: Astor, Gunderman, Hutnick, Nasisi, Opilla, Slater.

Vicky Schroeder, 60 Center St. spoke about getting information out to the residents who want to convert to gas and the cost to convert and also possibly have local contractors do the work. There being no further business from the public, Councilwoman Slater moved, Councilman Nasisi seconded motion to close the public session of the meeting.

Councilman Astor moved, Councilman Gunderman seconded motion to adopt the following resolution.

At 8:45 p.m. after returning from executive session Councilman Gunderman moved, Councilman Nasisi seconded motion to form a negotiating committee with Councilmen Robert Gunderman, David Astor, and Peter Opilla. Yeas: Astor, Gunderman, Hutnick, Nasisi, Opilla, Slater.

Councilman Nasisi moved, Councilwoman Slater seconded motion to reopen public session. Yeas: Astor, Gunderman, Hutnick, Nasisi, Opilla, Slater.

Thomas Mannion, 126 Kennedy Ave. explained to Council that he has gotten behind on taxes and would like an extension and also if it would be possible to keep it out of tax sale. The Mayor said he would look into the matter and would like to put something in writing. The Mayor also said he will need to speak with the Tax Collector and the Attorney.
