

**BOROUGH OF OGDENSBURG
ORDINANCE NO. 01-2022**

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 7 OF
THE CODE OF THE BOROUGH OF OGDENSBURG ENTITLED
“TRAFFIC” TO REGULATE VEHICULAR TRAFFIC ENTERING AND
EXITING THE OGDENSBURG ELEMENTARY SCHOOL’S MAIN
STREET HORSESHOE DRIVEWAY DURING SCHOOL ARRIVAL AND
DEPARTURE TIMES**

WHEREAS, the Borough of Ogdensburg (“Borough”) desires to regulate vehicular traffic entering and exiting the Ogdensburg Elementary School’s Main Street horseshoe driveway during school arrival and departure times in order to promote public health, safety, and welfare; and

WHEREAS, the proposed regulation is consistent with, and meant to further implement Policy 7480 entitled “Motor Vehicles on School Property” adopted by the Ogdensburg Board of Education on January 4, 2022.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Borough of Ogdensburg, in the County of Sussex, and State of New Jersey that Chapter 7 of the Code of the Borough of Ogdensburg entitled “Traffic” is hereby amended as follows:

SECTION I. Section 7-38.1 entitled “Regulation for the Movement and the Parking of Traffic on Municipal Property and Board of Education Property” is hereby amended to add new Section 7-38.1(d) as follows:

§ 7-38.1 Regulation for the Movement and the Parking of Traffic on Municipal Property and Board of Education Property.

- (d) Restrictions Applicable to Ogdensburg Elementary School’s Main Street Horseshoe Driveway. Vehicular traffic is prohibited from entering and/or exiting the Ogdensburg Elementary School’s Main Street Horseshoe Driveway during school arrival (7:45 a.m. – 8:15 a.m.) and departure (2:30 p.m. – 3:00 p.m.) times, Monday through Friday, except as follows:
 - (1) Use by school staff who have obtained school permission and who properly display a valid parking pass issued by the Borough Board of Education.

- (2) Use by parents and/or legal guardians of students with physical disabilities, who have obtained school permission and who properly display a valid parking pass issued by the Borough Board of Education.
- (3) Use by authorized emergency vehicles during medical or safety emergencies.

Any person who commits a violation of this section shall, upon conviction thereof pay a fine of not less than \$50 nor more than \$250.


SECTION II. In accordance with N.J.S.A. 39:4-198, the Borough Board of Education shall give due notice to the public by placing a sign(s) at the places where this ordinance is effective.


SECTION III. If any article, section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect.

SECTION IV. In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the Borough, the provisions hereof shall be determined to govern. All other ordinances of the Borough are hereby ratified and confirmed, except where inconsistent with the terms hereof.

SECTION V. This Ordinance shall take effect immediately upon final passage and publication according to law.


