**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 7 OF THE CODE  
OF THE BOROUGH OF OGDENSBURG ENTITLED “TRAFFIC” SECTION 7-10.  
TEMPORARY PARKING PROHIBITION FOR SNOW PLOWING AND REMOVAL**

**WHEREAS**, the Borough of Ogdensburg (“Borough”) desires to amend and supplement Chapter 7 Traffic Section 7-10 Temporary Parking Prohibition for Snow Plowing and Removal to add section 7-10.2 violations.

**NOW THEREFORE, BE IT ORDAINED**, by the Borough Council of the Borough of Ogdensburg, County of Sussex, and State of New Jersey, that Chapter 7 Section 7-10 Temporary Parking Prohibition for Snow Plowing and Removal of the Borough Code is hereby amended, revised and supplemented by adding Section 7-10.2 violations as follows:

**SECTION 1.**

**Chapter 7 Traffic**

**§ 7-10.2 Violations**

Any person (s) who is found to be in violation of this section shall be subject to a fine of \$100.00 for each violation.

**SECTION 2.** All Ordinances or parts of Ordinances inconsistent herewith are repealed.

**SECTION 3.** If any section, subsection, sentence, clause, phrase, or a portion of this Ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 4.** This ordinance shall become effective after second reading and publication as required by law.
