**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 7 OF
THE CODE OF THE BOROUGH OF OGDENSBURG ENTITLED
"TRAFFIC" SECTION 7-38 CONTROL FOR THE MOVEMENT AND THE
PARKING OF TRAFFIC ON PUBLIC AND PRIVATE PROPERTY TO
ADD SECTION 7-38.6.**

WHEREAS, the Borough of Ogdensburg ("Borough") desires to amend and supplement Chapter 7, Section 7-38 Control of the Borough Code entitled "Control for the movement and the parking of traffic on public and private property to add section 7-38.6.

NOW THEREFORE, be it ordained, by the Mayor and Council of the Borough of Ogdensburg, County of Sussex, and State of New Jersey, that Chapter 7, Section 7-38 of the Borough Code is hereby amended, revised, and supplemented by adding Section 7-38.6 as follows:

SECTION 1.

Chapter 7 Traffic

§ 7-38.6 Slow Children at Play Signs

Slow children at play signs shall be placed at the following locations

Name of Street	Side	Location
Passaic Ave.	East	50 feet east of Arch Street
Passaic Ave.		Behind 3 Wausau St. in the Borough right of way


SECTION 2. All other provisions unaffected by this Ordinance shall remain in full force and effect.


SECTION 3. All Ordinances or parts of Ordinances inconsistent herewith are repealed.

SECTION 4. If any section, subsection, sentence, clause, phrase, or a portion of this Ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 5. This ordinance shall become effective after second reading and publication as required by law.




