**AN ORDINANCE AMENDING THE SALARY OF THE TAX COLLECTOR AND
ADDING THE POSITIONS LABORER 1 – WITH CDL AND LABORER 1 – WITHOUT
CDL TO THE ORDINANCE FIXING THE SALARIES OF THE OFFICES AND
EMPLOYEES OF THE BOROUGH OF OGDENSBURG**


BE IT ORDAINED by the Mayor and Council of the Borough of Ogdensburg that;

1. The following position and salaries for the offices hereinafter set forth for the year 2025 will begin August 1, 2025 and be added to the ordinance fixing the salary to be paid for the offices which are set at fixed figures and the offices wherein a minimum and maximum range is set for the salaries, the salaries shall be paid to the holder and said offices within the minimum and maximum range set by resolution of the Mayor and Council:


	Minimum	Maximum
Tax Collector-----	\$4,000.00	\$70,000.00
Public Works Laborer 1 – with CDL-----	\$20,800.00	\$55,000.00
Public Works Laborer 1 – without CDL-----	\$20,800.00	\$48,000.00

2. The aforesaid salaries and positions shall take effect as of August 1, 2025.
3. This ordinance shall become effective upon adoption and publication according to law.


