ORDINANCE NO. 12-2025**

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 7 OF
THE CODE OF THE BOROUGH OF OGDENSBURG ENTITLED
“TRAFFIC” TO ADD STOP INTERSECTIONS.**

WHEREAS, the Borough of Ogdensburg (“Borough”) desires to regulate the passage and/or stopping of traffic at designated points along certain public roads located within the Borough in order to promote public health, safety and welfare.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Borough of Ogdensburg, in the County of Sussex and State of New Jersey that Chapter 7 of the Code of the Borough of Ogdensburg entitled “Traffic” is hereby amended as follows:

SECTION I. Section 7-24 entitled “Stop Intersections” is hereby amended, supplemented, and revised by adding stop intersections as follows:

<i>Intersection</i>	<i>Stop Sign(s) On:</i>
Arch Street and Passaic Ave	Arch Street
Wausau Street and Passaic Ave	Wausau Street


SECTION II. Stop signs shall be erected and maintained for the above designated stop intersections in accordance with the Manual on Uniform Traffic Control Devices.


SECTION III. If any article, section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect.

SECTION IV. In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the Borough, the provisions hereof shall be determined to govern. All other ordinances of the Borough are hereby ratified and confirmed, except where inconsistent with the terms hereof.

SECTION V. This Ordinance shall take effect immediately upon final passage and publication according to law.




