ORDINANCE 13-2021**

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 2, ARTICLE VII
OF THE CODE OF THE BOROUGH OF OGDENSBURG ENTITLED
“ADMINISTRATIVE FEES”**

WHEREAS, the Borough of Ogdensburg (“Borough”) desires to amend and supplement Chapter 2, Article VII of the Borough Code entitled “Administrative Fees” to provide for and update administrative fees required for licenses, permits, and use of Parks and Recreation Areas.

NOW THEREFORE, BE IT ORDAINED, by the Borough Council of the Borough of Ogdensburg, County of Sussex, and State of New Jersey, that Chapter 2, Article VII of the Borough Code entitled “Administrative Fees” is hereby amended and supplemented as follows:

SECTION 1. Section 2-63.5 entitled “Licenses, Permits, Records and Certificates” is hereby amended to add or replace the following fee provisions:

§ 2-63.5 Licenses, Permits, Records and Certificates.

Parks and Recreation Areas:

OGDENSBURG RESIDENTS

Boat Licenses (available to Ogdensburg residents only)	\$5 annually
Heater’s Pond Badge for swimming, fishing, and picnicking	\$5 per person annually \$25 maximum per family annually (single household)
Children 3 years old & under	\$1 per child annually
Senior Citizen (65 years or older with proper identification)	No Fee
Veteran (with proper identification)	No Fee

NON-RESIDENTS

Heater’s Pond Daily Guest Badge (must be accompanied by Ogdensburg resident having a valid Heater’s Pond Badge)	\$1 per guest per day (limit 5 daily guest badges per resident badge holder)

FACILITY USE FEES FOR GROUPS AND ORGANIZATIONS

Application Fee for Use of Municipal Facilities (due at time of application)	\$25 per application
--	----------------------

Pavilion Use Fee	\$100 per day
Daily Use Fee for Municipal Facilities	\$100-\$500 per day
Seasonal Use Fee for Municipal Facilities (3 or more uses per season, per facility) (fee to be determined at the discretion of the Governing Body based on the nature and intensity of the proposed use, and number of participants)	\$250-\$2,000 per season

* The Borough reserves the right to waive facility use fees for events or activities sponsored by the Borough, or any of its departments, boards, and committees.


SECTION 2. All Administrative Fees unaffected by this Ordinance shall remain in full force and effect.

SECTION 3. All Ordinances or parts of Ordinances inconsistent herewith are repealed.


SECTION 4. If any section, subsection, sentence, clause, phrase, or a portion of this Ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 5. This ordinance shall become effective after second reading and publication as required by law.
