WHEREAS, N. J. S.A. 40A: 11-1 et seq., the "Local Public Contracts Law" permits any board or agency which has administrative jurisdiction to contract for certain professional services without competitive bidding; and

WHEREAS, the Borough of Ogdensburg Board of Health has need for professional services of a Board of Health Engineer and an Attorney; and

WHEREAS, funds are available for this purpose; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A 11-1 seq.), requires that the Resolution authorizing the award of contracts for "professional services" without competitive bids must be publicly advertised.

NOW THEREFORE, BE IT RESOLVED by the Board of Health of the Borough of Ogdensburg as follows:

2. These appointments are awarded without competitive bidding as "professional" services under the provisions of the Local Public Contracts Law because the required services are performed by a person or persons authorized by law to practice a recognized profession.

RESOLUTION FOR LEGAL NOTICE PUBLICATION REQUIREMENTS FOR 2026

WHEREAS, the New Jersey Open Public Meetings Act requires that adequate notice of certain meetings be provided to the public; and

WHEREAS, P.L. 2025, c.72, approved on June 30, 2025, establishes new requirements pertaining to the publication of legal notices by public entities, including publication on a public entity's official Internet website, with most requirements becoming mandatory on or after March 1, 2026; and

WHEREAS, pursuant to P.L. 2025, c.72 after March 1, 2026, whenever a public entity is required by law or by order or rule of any court to publish or advertise a legal notice, the public entity must publish or advertise the legal notice on the public entity's official Internet website which shall be accessible to the public free of charge, with a direct hyperlink to legal notices conspicuously place on the public entity's homepage; and

WHEREAS, P.L. 2025, c.72 further requires public entities to maintain an Internet archive of legal notices that are no longer displayed, which must be kept for at least one (1) year; and


WHEREAS, between January 1, 2026, and February 28, 2026, the Board of Health shall also submit required legal notices to be advertised in the Borough's official newspaper the New Jersey Herald and Sunday New Jersey Herald in addition to posting said notices on the Borough website.

NOW THEREFORE BE IT RESOLVED; The Borough of Ogdensburg Board of Health hereby provides notice that all official legal notices that are legally required to publish or advertise will be made available for public viewing free of charge, on the Borough's official website at <https://ogdensburgnj.org/legal-notices/>. A direct hyperlink to <https://ogdensburgnj.org/legal-notices> will be conspicuously placed on the Borough's homepage.

1. Between January 1, 2026, and February 28, 2026, the Board of Health shall also submit required legal notices to be advertised in the New Jersey Herald and Sunday New Jersey Herald.
2. The resolution shall take effect immediately.

WHEREAS, Section 14 of the Open Public Meeting Act, Chapter 231, P.L. 1985 permits the public body to fix a reasonable sum to be charged to the persons who request that notice of meetings as required under the Act be mailed to them individually; and

WHEREAS, said sum is to cover the cost of providing such notice; and

WHEREAS, said section further permits the public body to provide such notice free of charge to news media who so request;

NOW THEREFORE BE IT RESOLVED, by the Ogdensburg Board of Health, County of Sussex, State of New Jersey, as follows:

1. Each person who requests that individual notice as required under the act be mailed, shall pay annually (\$.05) per page to cover costs thereof.
2. Request for such individual notice made by news media shall be granted without cost.
3. The sum herein designated is subject to change upon the adoption of superseding resolution by this public body.
4. This resolution shall take effect immediately.
